##### Health Effects

Skin	<p>For those products containing latex:</p> <p>The natural rubber latex may cause skin irritation and sensitisation (an allergic skin reaction) in some individuals. Symptoms may include: dry, cracking skin; skin sores or bumps; and/or itching or rash.</p> <p><b>Natural rubber latex allergy:</b> (caused by proteins in the latex). This serious allergy can cause severe reactions. Symptoms are: hives, skin rash, itching, swelling, sneezing, and/or difficulty breathing.</p>
Eye	<p>Padding material may release fibre that may enter the eye and cause minor irritation.</p> <p>No issue for other products.</p>
<b>First Aid</b>	
Skin	<p>Treat a melt burn as a thermal burn.</p> <p>For those products containing latex: Seek medical attention. Do not continue to use the product when the individual has become sensitised.</p>
Eye	Rinse eye with water to remove any fibre.

#### PRECAUTIONS FOR USE

Controls	Where padding material is used, ensure good dilution ventilation.
Protection	<p><b>For those products containing latex, persons with known sensitivity or allergy to natural rubber latex must NOT use the product.</b></p> <p><b>For ALGISITE M: Do not use on patients with a known allergy to alginates.</b></p> <p>No personal protection is required for any product used.</p>
Flammability	Combustible solid. Will burn under fire conditions. Padding materials may release a small amount of dust and loose fibre, that, if allowed to accumulate on surfaces, may cause a fire hazard. Loose material in a pile may be a fire hazard.

Storage and Transport	Store in cool, dry, well-ventilated area away from strong oxidising agents. Observe specific labelled storage requirements. No special transport requirements.
